ATHLETE ARRIVAL: You should plan to arrive no later than 8:30 AM **Saturday, March 14th, 2009** in order to insure proper registration.

COMPETITION DATE: **Saturday, March 14th, 2009**

ENTRY FEES: 1 or 2 Individual Events = \$55.00.
Team Form = \$45.00.
Coach's Credential fee = I would like 2 black belt from each school to step up and participate in the officiating. (Better to have the Instructor and one black belt) remember the parents of your students can help be coach's.

CLINIC FEES: Indiana AAU Officials and Coaches Clinic Fee Schedule will be as follows:

1st Time Course Fee = \$35.00.

Refresher Fee = \$35.00.

All clinic attendees will be issued an official AAU Taekwondo certification card and certificate.

All officials and coaches who wish to work this event **MUST** hold a current **(2009)** AAU Taekwondo license and attend the respective clinics.

ENTRY DEADLINE: All applications must be postmarked no later than **Saturday February 21st, 2009**.

LATE FEES: Applications postmarked after **Feb 21st**, and before **Feb 28th, 2009** may still be accepted **BUT WILL BE ASSESSED A \$15.00 LATE FEE (NO EXCEPTIONS)**. *No applications postmarked after **Feb 28th, 2009** will be accepted.*
ABSOLUTELY NO APPLICATIONS WILL BE ACCEPTED OR CONSIDERED AT THE DOOR.

AAU MEMBERSHIP: *All athletes, coaches and officials **MUST** be individual members of the AAU and **MUST** present their membership card at the time of their check in for the officials/coaches clinic and/or the competition.*

*This event will qualify the top eight (8) athletes in each appropriate age and division to participate in the **2009 AAU NATIONAL CHAMPIONSHIPS**, which will be held in **July** in Fort Lauderdale, Florida.*
